


REPORT: How much trade transits the South China Sea?

Report by “China Power” Project of CSIS

In broad terms, ChinaPower examines five interrelated categories of Chinese power: military, economic, technological, social, and international image. Since Chinese power cannot be evaluated in a vacuum, each element of power is compared with other relevant countries.

- Nearly 40 percent of China's total trade in 2016 transited through the South China Sea.
- 64.1% of China's maritime trade transited the South China Sea in 2016.



China continues to enjoy strong growth—projected at 6.7 percent for 2017. And the country has potential to sustain strong growth over the medium term. But to do so safely requires speeding up reforms to make growth less reliant on debt and investment, the IMF said in its latest annual assessment of the economy.

Here are the six things you need to know about this report.

IMF staff have revised up China's growth outlook compared to last year's report.

But at a cost of higher debt, which leads to rising risks

Given strong growth momentum, now is the time to intensify deleveraging efforts.

Chinese purchases of overseas ports top \$20bn in past year -16th July

With the aim to dominate maritime industry China has been acquiring overseas ports with huge investments which crossed USD 20 bln last year, Financial Times reported.

Beijing has spent billions expanding its ports network to secure sea lanes and establish itself as a maritime power, says the report.

The report quoted a study by Grisons Peak, a London-based investment bank, found that Chinese companies have announced plans to buy or invest in nine overseas ports in the year to June in projects valued at a total of \$20.1bn.


